## Part Two "Who will guard the guardians?" - Juvenal, Satires

- A- Rafer Johnson and the gun:

  George Ross Clayton/Michael Wayne (is it Ross or Gregory?)
  It will be remembered that Item #24 and Item #25 were photographs and film cannister. However those same item numbers (24 & 25) were also the item numbers for the RFK fatal bullet and fragments.
  Years later when Jamie Scott Enyart sued LAPD for the return of his pantyy scene photos and film cannister he was given the Clayton items 24 & 25. Then during the trial the film cannister was "stolen" from the vehicle of the courier who was divivering it from California State Archives. Enyart won his lawsuit and I do not buy that "stolen film cannister" story. Do these folks simply do what they want to thwart justice? Apparently so. If there is but one glaring deception in this entire case it is the "stolen" film cannister. It should be remembered that the film cannister contained Scott Enyart's pantry scene negatives which the Enyart judge ordered delivered to the court.
- L- For years this fraudulently created document puzzled me, then finally last week I indeed discovered positively irrefutable proof that this specific Jake williams Property Report written by LAPD is a fake. Pure and simple and I ask crime labs and examiners of questioned documents to please examine my stinging discovery.

In brief this is the story: LAPD criminalist DeWayne Wolfer testified in February 1969 that the gun he used (for sound and tattoo tests), the Jake Williams gun (H18602) is "still available". However, this was untrue because the gun was destroyed in July 1968 as several official documents report. Now, it is perfectly plausable that Wolfer simply erred and did not lie when he testified that the (other) gun was still available. He might have been unaware of the July '68 destruction. This is entirely possible in light of the fact that gun H18602 most certainly should have become evidence in Sirhan case since it was used for test purposes. Additionally, it was not the Sirhan gun which was used for comparison test bullets (with victim bullets), it was the Jake Williams gun H18602 - and this is seen on evidence envelope People's 55 during Sirhan trial but bearing the Williams gun number on the 6-6-68 water recovery test. See photos of evidence envelopes in my reports.

Here is my discovery: examine the positioning of the bottom binder holes and the binder holes at the left of each copy of the Jake Williams Property Report. The damaging report with the stamp "DESTRORED JULY 1968" supported the CII teletype date of destruction july 1968. Additionally there are other official cards which show destruction of H18602 in July 1968. Please superimpose all of the Jake Williams Reports for EXACT line-up of the mandwriting.

The substituted Jake Williams Property Report is without a doubt a falsely created document.

M- If these documents are to be believed then this is a clear violation of Judge Arthur Alarcon's Court Order which sealed the evidence in the custody of the Los Angeles County Grand Jury on June 7, 1968.

Here are the background facts re this court order violation:

The alleged Sirhan gun was turned over to the custody of LACGJ on 6-7-68, however there was no record of the gun's ID number.recorded anywhere in the LACGJ transcript. The enclosed documents show that gun H\$3725 (the gun ID currently housed in the California State Archives) was transferred to SUS on August 24, 1968. This is a clear and flagrant violation of Judge Alarcon's court order. Remember, that Wolfer used the Jake Williams gun (H18602) because the Sirhan gun Wak required a court order to access it (see documents in L above).

- N- The Los Angeles Police Department Property Report referencing Item 71 differs in two separate copies of the same item number. This difference amounts to a deliberate obfuscation of information about the hidden torn gun label (from the gun box). For a full explanation of this affair I ask the reader to examine my book Robert F. Kennedy/Sirhan Evidence Report as well as my Special Exhibit 10 Report in the first part of this web site.
- O- Munir Sirhan purchased the gun from co-worker George Erhard for 25 dollars. Sirhan contributed seven dollars of the purchase money.
- P- Sirhan's "diary" Only legible pages used.
- Q- Additional documents and photographs. Includes Fair Play to Cuba Comm. document.

In conclusion - I feel there isn't a crime lab in the world which would defend this abysmal record of wrong-doing and outright fraud in many instances of the evidence in Sirhan/Kennedy case. Especially is it egregious that there is a woeful lack of a chain of custody for nearly all of the ballistics evidence. Even the Ninth Commandment admonishes us: "Thou shalt not bear false witness against thy neighbor."
